Ngatikahu ki Whangaroa Claimant Funding Request

Purpose

1. This memorandum seeks your approval to the release of \$50,000 of claimant funding to Ngātikahu ki Whangaroa from their claimant funding allocation. The proposed release would allow Ngātikahu ki Whangaroa to progress building a website and re-enter discussions with the Crown towards a deed of settlement.

2. Recently Cabinet authorised the Secretary for Justice to release claimant funding within the amounts set aside for each milestone from the overall claimant funding amount [TOW Min (09) 6/4 refers].

Background

3. In April 1999, Cabinet delegated authority to the Minister for Treaty of Waitangi Negotiations to release claimant funding in instalments once an overall funding limit has been approved [CAB (99) M11/20 refers]. In June 2006, Cabinet approved modifications to the claimant funding policy [CAB Min (06) 11/17 refers].

In June 2009, Cabinet approved further modifications to the claimant funding policy [TOW Min (09) 6/4 refers]. The Minister for Treaty of Waitangi Negotiations and the Minister of Finance subsequently agreed that Ngātikahu ki Whangaroa receive an allocation of pf claimant funding as a contribution to expenses incurred in negotiating their deed of mandate, terms of negotiation, agreement in principle, deed of settlement, ratification, legislation and governance workstreams.

The proposed release is within your delegated financial authority as Secretary for Justice [TOW Min (09) 6/4 refers]. The proposed release is appropriated through the non-departmental other expense appropriation: Claimant Funding. There is sufficient funding for the proposed release.

Claimant funding request

6. Ngātikahu ki Whangaroa have requested the release of \$50,000 of claimant funding. Officials are satisfied that the information they have provided shows they have incurred \$30,000 of legitimate negotiation costs against the previous release of \$30,000.

Progress in negotiations

- 7. Ngātikahu ki Whangaroa signed an agreement in principle milestone with the Crown on 22 December 2007. Negotiations have been in abeyance for the last year as attempts failed to resolve the occupation of Stony Creek. Ngātikahu ki Whangaroa met with officials on 24 September 2010 and provided a number of options to move forward to settlement.
- 8. Further to this Ngātikahu ki Whangaroa would like to create a website to provide better information to their people. We are supportive of this and recommend the funding be released to enable them to create a website.

Remaining claimant funding

- 9. If you approve the claimant funding request, will remain available to Ngātikahu ki Whangaroa for signed deed of settlement milestone.
- 10. A total of of claimant funding will remain to enable Ngātikahu ki Whangaroa to complete the settlement process.

note that if you approve this recommendation, Ngātīkahu ki 4. Whangaroa will have from their deed of settlement etaimant funding milestone unspent.
