Query from W. Wood: As Ella is no longer a Negotiator, what is her role on the Trust Board? **Ella's role is temporary only as Communications Adviser for the Trust Board,** until such time as someone is elected to the position, that remains to be dealt with at this meeting. The Communication Strategy has been presented to the Board, so she no longer has a role, other than as a Whanau member of the Trust Board.

J Paterson: Does not accept that Ella should leave that position at this stage.

C McKenzie: Supports John's view. We do need someone now.

W Wood: Objected to not being notified of the meeting between the Crown and the Trust Board on 21 February 2008 in Auckland. Kaitangata should have attended. Decisions already finalised – NOT GOOD ENOUGH!

REPORTS DIRECT TO MICHAEL CULLEN ON MAORI LAND, CULTURAL AND MEDIATION ISSUES.

Had been invited to report on his meeting with Ngati Aukiwa (along with Ben Dalton – apology for absence).

He and Ben had been approached by Darren Hobson to mediate for Ngati Aukiwa. They first met at Waitaruke Marae where they were told by OTS to 'butt out!'

Second meeting at Waimahana was initiated by OTS that he attended with Ben Dalton. He collated 5 points for consideration:

- 1) Stoney Creek Farm be returned to Ngati Aukiwa unencumbered. (no debts etc)
- 2) Interim Joint Management of Stoney Creek Farm be arranged to negate need for security.
- 3) Income/Expenditure of Stoney Creek Farm be fully disclosed.
- 4) Meeting between representatives of Ngati Aukiwa and Dr Cullen be arranged to put their case.
- 5) Current 'Truce' between Ngati Aukiwa and other parties be maintained. (Cannot give assurances of last point).

J Paterson: Has anything been resolved in Aukiwa? - No. Is OTS aware of these points? - Yes

K Prime: Minister genuinely wants to find solution to whole situation. Crown wants to avoid the 'Settlement Process' because of the continuing divisive impact on the Community.

- 1) Is it feasible to contemplate meeting with Ngati Aukiwa? Dr Cullen keen to progress this.
- Will the Trust Board consider an arrangement that Ngati Aukiwa people be trained to manage Stoney Creek Farm?

Response: 1) Not likely/ feasible – insufficient member numbers in Aukiwa – Crown would be reluctant to agreement. Response: 2) Crown has offered to pay for training.

E Henry: Treaty Settlement Policy of negotiating with Iwi only, not Hapu – has that changed? Ngati Aukiwa is not an 'Iwi'.

K Prime: Would Trust Board be able to provide specific input into Governance arrangement?

M Poto: Not just for Aukiwa, must include all 6 Marae Whanau.

S Heihei: There is no 'truce' with Aukiwa Whanau – nothing is happening. There has been a lot of negative media attention, and statements made unofficially. OTS has expected the Trust Board to do something about the current situation on Stoney Creek Farm.

M Thomas: Was present at Waimahana Hui, wasted time in mediation. Did not meet Cullen. Stock taken from M Peterson's farm, must be returned. Aukiwa accused of happenings at Farm. OTS cannot give anything back, we already own it. Talking about profits, why should we pay 25% back to the Crown? We suggest getting rid of the Trust Board, we will settle with the Crown for Stoney Creek Farm. Waimahana always open to Whanau.

C McKenzie: Was twice turned down from going to Waimahana Marae.

D Manuel Jnr: When he represented Waimahana on the Trust Board, he was never allowed back to the Marae. Now they are calling Mangawhero names.

E Henry: will never go back to Waimahana Marae.

E Peterson: Give the full story. What happened to my letter dated 24 May?
